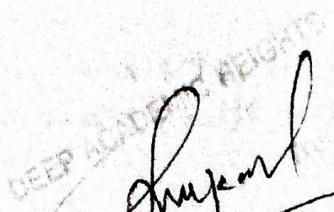

AND WHEREAS the Trustees have at request of the Settlor agreed to act as Trustee is evidenced by their signing these presents.


1) NAME OF THE TRUST

The name of the Trust shall be "**DEEP ACADEMIC HEIGHTS**" hereinafter called the Trust,

2) OFFICE UNITS AND BRANCHES

The Trust shall have its Registered Office at Howrah where all the book of accounts of the belonging to the trust shall be kept and/or maintained, and wherefrom the activities of the trust with the administration and management of the trust shall also be governed. This office may be shifted or extended to any place or places anywhere in India if so desired by 2/3 rd majority of the Managing committee. Beside this , branch office/s and or unit/s may be

3) DEFINITIONS

In the interpretation of this deed, unless the context otherwise requires the following words and expressions shall have the following meanings respectively attached thereto:


- (a) **The Financial Year**- means the period beginning with the 1st day of April in any year and ending with 31st day of March of the succeeding year. The first year, however, shall commence, from the day of execution of this deed and ending on 31st March, 2017,
- (b) **The Trust Fund**- means the said sum of Rs 10000/- (Ten Thousand Only) handed over by the Settlor to the founder trustees constituting the said fund and all donations wherever in money or in property movable and/or immovable of any kind and/or all additional moneys which may, from time to time be collected by the "Trustees" and all money and/or properties of every kind given, donated or bequeathed for the purpose of the Trust and all other additions thereto and the investments and properly for the time being representing the same and all moneys, shares, stocks, fund, securities and other properties movable and immovable which may under the Trust and provisions of these presents be substituted or added thereto and for the time being subject to the Trust deed.
- (c) **Trustees**- mean all the founder trustees of the trust and any other person who is admitted as a trustees by the Management Committee of the Trust.

4) OBJECTS OF THE TRUST

The objects for which the Trust is created are:

- i) Relief to the poor and indigent people.
- ii) Medical relief
- iii) Advancement of education.
- iv) Promotion and development of scientific, literary and cultural activities.
- v) Rural development.
- vi) Any other activity of general public Utility.



In order to achieve the objects of the Trust the trustees shall not undertake any activities that make distinction as to religion, caste, colour, culture, sex or creed and for such purpose.

- a) To undertake and execute any research and development, programme for new invention and development of better ideas in scientific, industrial, medical, educational and cultural fields for the benefit of the public in general.
- b) To establish, maintain or grant scholarships, loan-scholarships, and/or establish lectureship fellowship, readership, researches, stipends, prizes and other academic rewards, allowances and also other aids and remunerations to students, scholars, research students, teachers, artists literatures, musicians, writers, technicians and other similar person or person engaged in the study and research on Science, Literature, Arts, Nature Cure, Medicine, Law, Engineering, Technical, Musical, Agriculture and vocational course with a view to the advancement of literature, art, culture and Knowledge
- c) To confer medals, to supply books, allowance for travel expenses and/or other financial assistance/incentives in cash or in kind or otherwise including the provisions of boarding and lodging to poor and other deserving students/other persons for studies and for advancement of educations cultural activities and public utilities.
- d) To organise debates, lectures, seminars, symposia, conferences and performances with a view to make the general public familiar with and to appreciate the qualitative trends of social, literary and artistic thoughts, researches and experiments, to provide educational and social services, to hold conference for removal of illiteracy, Drug awareness etc.
- e) To acquire, establish, promote, set-up, support, maintain, run, assist, support and / or grant aid or other financial assistance, give contribution and / or donation in cash and / or in kind or otherwise in all manner to help in the setting up and / or maintaining and / or running of schools, colleges, universities, libraries, reading rooms, student hostels, lecture halls, exhibition, museums, research institutions, laboratories, music and cultural institution, sports institution including water sports, adult education centres, institutions for the blind, deaf, dumb and otherwise handicapped and other establishments and institutions for the promotion, advancement and development of education and diffusion of knowledge.





- f) To acquire, establish, construct, promote, set-up, renovate, repair, run, maintain, assist, support and/or grant give contribution and/or donation of other financial assistance to or help in the setting up and/or maintaining and/or running or repairing dharamshallas, gaushalas, musafirkhanas, pravachan places, religious place or places or a place of public of public worship, public roads, parks, tanks and cultural stadiums, rest houses, holiday homes, child welfare, orphanages, window homes, women welfare & development centers and such other instauration which may be useful for the public.
- g) For reception and treatment of persons suffering from physical or mental illness or for providing medical and allied facilities to persons during convalescence and for taking care of persons requiring medical attention and rehabilitation and for promotion of research and education of medical science, for making aware and work for prevention of all diseases and for that purpose.
- i) To acquire, establish, promote, set-up, run, co-operate, sponsor, maintain, assist, support and/or grant aid other financial assistance, contribution and/or donation in cash or in kind or otherwise to help in the setting up and/or maintaining and /or running including unani, Homoeopathic, Allopathic(Medical and/ or Surgery), Ayurvedic, yogic, Naturopathic or any alternate services for relief of human being both physically and mentally, medical schppls/colleges, nursing homes/institutions, sanatoria, nature cure centers, maternity homes, clinics, charitable dispensaries, mobile dispensaries, child clinic/homes, gymnasiums yoga institution, after care clinics, child welfare centers, family planning centers, rehabilitation centers, convalescent homes, physical and cultural homes, sporty center including water sports, orphanages home for the infirm, aged disabled/physically handicapped, diagnostic centers ,medical centers including all its auxiliary and supporting units and departments including 'X' ray, pathology, Radiology, Physiotherapy, Blood Bank, Laundry, Kitchen, Cafeteria, Drug Stores etc, and other similar institution and establishment for the benefit and use of the public in general and advancement of their health. To organise, supportsponsor, set up blood donation/collection camps, free eye operation camps, medical bank/camp, medical, testing and operation camps.





- ii) To undertake activities for the treatment of cancer patients in the form of diagnostic camps, treatment (palliative and curative) and rehabilitation/ hospices and palliative care center. To establish, set up, promote, organize, run, manage, conduct and encourage research laboratories to conduct research and experiments in all type of diseases including Cancer, AIDS, Cardiac ailments, Urology, Neurology etc. and to undertake and carry on research, experiments, tests related to various medical disciplines.
- iii) To establish, set up, promote, organize, run, manage, conduct and encourage medical research institutions and research programmers in any branch of medical science by engaging or employing leading Doctors, Physicians, Scientist, Consultants, Technicians, Experts on such terms as the Trustees thinks fit and to give such persons remuneration, honorarium for their engagement. To award fellowships related to Medical Science and to support students, researchers in medical field.
- iv) To give advice on, publish research papers and/or otherwise promote utilization of research result in the medical fields. To promote, develop and improve scientific exchange of knowledge as well as technical co-operation between research institution with similar interests and objectives. To conduct conferences, refresher courses, lecture, debates, discussions, excursions, seminars, public health education and promotion activities, demonstration and exhibition relating to the research done, knowledge generate and result obtained and to diffuse, promote and propagate the knowledge of disease.
- v) To preach the message of prevention, diagnosis as well as curative aspects of all diseases affecting and to awaken consciousness of the natural history of the diseases, especially to the developing communities, and rural areas.
- vi) To prevent, correct and manage environment hazards especially related to arsenic and fluoride-rich drinking waters, air, sound and other pollutions.

h) To acquire, establish, promote, set-up, run, maintain, assist, support and / or grant aid or other financial assistance to or help in the setting up and / or maintaining and / or running to homes for widows and destitute, orphanages, child welfare centres and likewise other institution, associations societies or establishment for relief of and to give help to the poor and destitute people, orphans and widows and other needy people including establishment and maintenance of training and welfare centre for them.


- i) To undertake, carry out, promote, establish, set up, conduct, aid help or otherwise support, sponsor rural development and uplift including any programme for promoting the social and economic welfare of, or uplift of the public in any rural area and to incur expenditure on any programme of rural development and to assist, aid, help, execution and promotion thereof either directly or through an independent agency or in any other manner.
- j) To provide, grant, give financial and other assistance to and to make such arrangements which would help in the upliftment of the poor, harijans, adiwasis. Backward people, rural communities destitute people, orphans, widows, the aged, infirm and physically handicapped and otherwise provide for their welfare and uplift.
- k) To establish, maintain, support, acquire, run and/or grant aid to institutions / centres for the promotion, popularisation, appreciation and development of science, literature and fine arts which are conducive to the benefit of the public in general. To promote national integration by establishing places for social, cultural and spiritual congregations, inter actions and discourses.
- l) To install, establish, maintain, assist, support and / or grant aid in cash or in kind or other financial assistance to or help in for the installation, establishment, constructions, repairs, running and /or maintenance of tube wells, water huts, water supply equipments and pipe lines and water works and other drinking water supply facilities for the supply of water for the use of the public in general places of public importance, hospital, educational institutions etc, and for rural development. Establishment of research laboratories, establishments, centres etc for searching out or utilisation or conservation of water and its sources for betterment of agriculture and health in the country.
- m) To grant relief during and to persons stricken with natural and national calamities such as famines earthquakes, floods, drought, fires, riots, pestilence and also during civil commotion, other distress and acts of God and other occasions of calamities of similar nature and to give donations, subscriptions or contributions in cash or in kind to institutions, establishments or persons for doing such relief work.



- n) To render assistance and/ or grant financial or other aid to recognised public charitable trusts or institutions.
- o) To create, promote, settle, establish and/or start any other charitable trust and/or institution for the benefit of the public in general.
- p) To purchase, store and maintain articles, furniture and utensils of general public utility and lend the same to poor and needy persons at the time of marriage and/or any other occasions.
- q) To appoint as apprentices to any profession, trade, industry, or institute for the training of person in technical, mechanical, scientific and other pursuits and make provision for their upkeep and maintenance and to assist in obtaining employments.
- r) To establish, equip and maintain industrial educational homes and to arrange regular programmers in order to induct appropriate knowledge of and for teaching all such technology, mechanical, industrial, engineering, commercial, agricultural, arts , handicrafts and home industries including carpentry, designing, drawing, painting, photography, art work, carpet making, spinning and weaving, laundry work, dry cleaning. Cooking confectionery, knitting, sewing, embroidery, printing and other industries and skills and other job oriented techniques, knowledge etc.
- s) To establish and maintain Home at rent or at concessional prices, free home and to undertake project to provide, shelter, food and other necessities to old, destitute, homeless, needy and incapacitated persons. To organize relief for distressed people directly or indirectly and to render all humanitarian services etc. to the people at large.
- t) To supply necessities to the poor, needy and incapacitated persons free and/or at concessional prices.
- u) To arrange regular programme to make common aware in general regarding pollution control, against drug abuse, betterment of environment, upliftment of moral value and for betterment of public and to undertake programmes for or any way to assist any organization for attainment of above objects.

v) To do such other charitable acts, deeds things to provide for the advancement of other objects and upliftment of general public utility and the people in all ways and for their educational medical and social welfare related with the above and/or otherwise without distinction as to religion, casre, colour or creed.

w) To establish, provide, maintain and conduct or otherwise subsidies research laboratories and experiment for scientific and technical research and experiments and to undertake and carry on with all scientific and technical researches, experiments and tests of all kinds and to promote studies and research, both scientific and technical investigations or inventions by providing, subsidizing endowing or assisting laboratories, workshops, libraries, lectures, méeting and conference and by providing for the remuneration of scientific or technical professors or teachers and by providing for the aware of exhibitions, scholarships, prizes and grants to students or otherwise and generally to encourage, promote and reward studies, researches, investigations, experiments, tests and inventions of any kind.

x) Protection, preservation or improving the live-stock, which is beneficial to human beings

y) To provide, grant give financial and other assistance, contribution and/or donations in cash and/or in kind of otherwise to and to make such arrangements, establish, co-operate, support, sponsor, promote, acquire, maintain, run, grant. Aid. Give to all manner or otherwise for religious purposes, activities to extent or as may be permitted by statute and in particular by the Indian Income Tax Act.

z) To do all acts, deeds and things as may be necessary for or in relation to or conductive to the attainment of the above objects or any them.


PROVIDE FURTHER that the objects of this trust shall always be in consonance or in conformity with such objects as would be considered charitable in nature under the law of the country including the tax laws applicable to charitable trust for the time being, so that it may not lose its character of charitable nature as defined or laid down in any such laws and in particulars under the Indian Income Tax Act, as amended from time to time.

5) PROHIBITION

i) That none of the objects of this trust shall at any time involve carrying of any activity for profit.

ii) That the income or the assets of the trust fund shall not be applied or transferred any time whole or in part for any purpose, other than public charitable and welfare purpose.

6) **POWERS**


1. To establish and run or cause to be established and run schools, colleges and student homes, To give donations to any other Trust/Society having similar objects.
2. To grant scholarships, stipends and financial help to deserving students to enable them for their studies for purchasing books and other equipments.
3. To establish press and to publish newspapers, magazines, pamphlets, leaflets, maps, periodicals, bulletin and books and to use audio-visual media for propagation and education.
4. To establish and manage or cause to be established and managed libraries and reading rooms.
5. To make mass contact in the urban/rurai areas in India and abroad and organize various programmes for collection of funds for furthering the object of the Trust.
6. To establish and maintain or to contribute towards establishment and maintenance of hospitals, dispensaries, medical centres, maternity planning and nursing homes.
7. To collect donations and to do relief work at the time of national or natural calamities like war, flood, earthquake, fire, riots and refugee relief camps.
8. To deposit the funds in a Nationalized or scheduled Bank or post office and invest its funds in Government, Securities or shares or debentures or securities of any company or co-operative Trust or any security, loans, issued by Central or state Government, Municipal or local authority or public body in India.
9. To accept any gift, donation (including in Foreign Exchange) and to purchases, take on lease or acquire any property (Whether movable or immovable) or any rights or privilege for the purpose of the Trust.



10. To raise loans with or without interest on such terms and condition as the Executive Committees from nationalized bank, public financial institutions or private financial institutions may decide from time to time.
11. To do all other acts, deeds and objects of general public utility as may be necessary or deemed expedient.
12. To carry out all or any of the objects aforesaid or such other objects as are similar to the said objects without any profit motive.
13. To sell, dispose of alienate or otherwise deal with any property comprising the trust fund.
14. To open and maintain banking account or accounts from time to time in the name of trust with any bank or banks and to operate such account in the name of trust and/or institutions run/conducted by the trust and to give instructions to the bank and to provide for opening and operation of such accounts by the president along with secretary or treasurer.
15. To make, vary, alter or modify scheme, rules and regulations, for carrying out the objects of the trust and for the management of the affairs thereof and/or running any institution in furtherance of the object of the trust and otherwise for giving effects to the object of the trust.
16. To give aid way of donations out of the income or the corpus of the Trust fund or otherwise to different charitable institution, societies, organization or trust in India which may have been established or which may be established for the like charitable purpose mentioned in these or any of them to enable such institutions, societies, organizations or trust to maintain, or carry out such charitable objects.
17. To take over or amalgamate with any other trust, society, association or institution having similar objects.



18. To establish press and to publish newspapers, magazines, pamphlets, leaflets, maps, periodicals, bulletin and books and to use audio-visual media for propagation and education.
19. To acquire, furniture fittings, fixtures, instruments, books and other equipments as may necessary for the purpose of the trust.
20. To establish and run or to help for establishing and running, training centres for training of preachers, instructors, missionaries organizers and other social workers.
21. To identify the sensitive areas which require immediate attention and to guide the intending about suitable projects of their choice.
22. To carry on any activity to the extent possible without affecting the registration of the trust for the purpose of obtaining or continuing exemption of the income of trust from Income Tax and other Statutes.
23. To undertake fund raising programme like inviting public donations for fulfilment of the objects mentioned above.
24. To enter into any contracts for furtherance of the objects and other ancillary activities of the trust.
25. To appoint, promote, demote, suspend or dismiss staff, officers or other employees of the Trust for carrying out the objects of the trust and to remunerate such persons.
26. To raise or borrow moneys subject to the consent of 2/3rd majority of the managing Committee required for the purpose of the Trust upon mortgage or pledge of the Trust property or part thereof without any security and at such rate of interest on such terms as to repayment or otherwise as they may deem fit.
27. To acquire on lease or by purchase or otherwise and/or construct any immovable property for utilization in achievement of any of the objects of the Trust and to let out, lease out and/or demise any immovable or other property comprised in the trust fund for such period and at such rent, on such terms and conditions as the trustees in their discretion may think fit.

28. The Trustees may at their discretion appoint constitute attorney (s) or agent(s) and to delegate to such attorney(s) or agent(s) any of the powers vested in them under these presents and from time to time remove such attorney(s) or agent(s) and to appoint other in his or their place.
29. To apply for and accept grants from the Government of India, public bodies, district bodies, corporations, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance so as to further the objects of the trust and for discussion and negotiation with these bodies.
30. The Trustees may make, vary, after modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and of running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
31. To apply for loan to any nationalised banker or public financial institutions and to hypothecate/mortgage the properties of the trust to achieve the aim and object of the trust and execute the deed on behalf of the trust in favour of the financier and receive the payment.
32. The Trustees may start, abolish, discontinue and restart any charity or charitable institution for the benefit of the general public and to impose any rules and conditions with regard to their operation or functioning.
33. The Trustees may set apart whole or any part of the income or the corpus funds of the Trust for spending in future for all or any of the object of the trust in accordance with the provisions of law including the income-Tax law applicable for the time being in force.
34. The Trustees shall be entitled to institute, defend , prosecute, continue, compromise any suit, appeal, revision, reference, civil, criminal, insolvency, revenue, income tax etc. matters before any court, tribunal, public office, statutory body, commission, judicial proceedings, quasi-judicial proceedings and to sign pleadings, petitions, affidavits, tabular statements, statutory notice and all other documents as may be necessary in such proceedings on behalf of the Trust either in any of the above matters or in respect of any properties belonging to the Trust without being liable for any loss occasioned thereby and for the said purpose to appoint and engage on behalf of the Trust

pleaders, Attorneys, Solicitors, Advocates or Barristers, Counsels and/or other legal practitioners, Chartered Accounts as the Trustees may think proper and to sign, verify and to execute Warrant of Attorney, Vakaltnama, Mukhtarnama, appointment letter and/or any other authority in connection therewith. The Trustees may delegate power to one or more trustees and/or appoint constituted attorney(s) or agent(s) and to delegate to such attorney(s) or agent(s) any of the powers vested in them under these presents and from time remove such attorney(s) or agent(s) and to appoint others in his or their place.

7) RULES FOR ADMINISTRATION OF THE TRUST

1. Eligibility of Member :-

A person shall be disqualified for becoming member of the trust if,

- a) He is declared to be of unsound mind by a competent court or
- b) He is an un-discharged insolvent or,
- c) He has been convicted for an offence involving moral turpitude; or
- d) He is minor, or
- e) He is considered to be unfit for being nominated as a member of the trust due to serious ailment

2. Ceasing of Membership

A person shall cease to be a trustee in any of the following events-

- a) If he is involved or has been convicted for an offence concerning moral turpitude or any other heinous crime.
- b) If he resigns his office; or
- c) If he is suffering from virulent form of leprosy or any other venereal disease
- d) If he becomes insane or otherwise become incapable to act; or
- e) If his activities are prejudicial to the interest of the trust or
- f) If he is absent continuously in the meetings of the trust for last four meetings.
- g) Any other matter which may be provided by the majority decision of the trust;

3. Meeting-

General meeting of the Managing Committee shall be held at least one in a year. However with the consent of president, at any time, meeting can be called upon.

4. Period of Notice

Notice period shall be minimum of 7 days. However it can be reduced on the event of any emergency, with the consent of president.

5. Quorum

Personal attendance of 1/3 members or two members of the managing committee whichever is higher shall be quorum. In case present members are less than two members, the meeting shall be adjourned for the next week on the same day, same place and same time, for which no quorum shall be required.

6. Managing Committee

Overall management of the Trust and custody and control and management of the Trust Fund shall remain vested in capacity of Managing Committee of the Trust and President of the Trust, Sri Shankar Prasad Shall hold office of the President cum Founder in his lifetime unless he himself relinquishes such office or otherwise becomes incapable or is subjected to any other disqualification. However till appointment/election of new president Vice President/Secretary shall hold the office.

A managing committee shall be formed amongst members of the trust which shall be valid for a terms of five years and thereafter fresh management committee will be formed by majority decision of the members of the trust in general body. The election shall be held for the post of Secretary and treasurer only and Sri Shankar Prasad President Cum Founder of the trust shall remain lifetime president of the trust and he has a right to appoint by will the President of the Trust for future and confer him such powers as he had as Author of the Trust. In case the President is not appointed by will the Managing Body will appoint any member of the managing body of the Trust by election/selection as the President. If the President is appointed by the Managing Body he will not have the special powers conferred to the Author of the Trust. In case any office bearers are appointed as President, his office will fall vacant and that will be filled up by the Managing Body of the Trust among the members of the Managing Body.

- (i) The President of the trust will be President of the General Body of the Trust, all the committees of the Trust and the institutions run by the trust.
- (ii) To preside all the meetings of the Executive Body, General Body of the trust, committees of the Trust.



(E) SPECIAL POWER OF THE AUTHOR OF THE TRUST





DISSOLUTION


